



## Announcement of Dongkhui Police Station

Subject: Anti-Bribery Policy (Anti-Bribery Policy) and not accepting gifts or any other benefits (No Gift Policy)

from performing duties Fiscal Year 2023

According to the Organic Act on the Prevention and Suppression of Corruption B.E. 2561 Section 128 paragraph one prescribes that any state official is prohibited from accepting assets or any other benefits that may be calculated as money from anyone. In addition to assets or benefits that are legitimate by laws, rules or regulations, issued by virtue of the provisions of law Unless accepting property or any other benefits by morality according to the criteria and amount prescribed by the NACC and the Code of Ethics of Police Officers, 2021, Article 2(2) with honesty. perform legal duties Regulations of the Royal Thai Police with transparency Do not show behavior that implies exploitation. Responsible for human rights duties. Be ready to be audited and liable, have a good conscience Considering the society and Article 2(4), thinking of the public interest rather than the personal benefit, having a public mind, cooperating and sacrificing for the benefit of the public. And create benefits and happiness for society, together with a national reform plan for the prevention and suppression of corruption and misconduct. (Revised version) Determine important reform activities. Activity 4: Develop the Thai bureaucratic system to be transparent and useless. Goal 1, item 1.1, is for every government agency to announce that all government officials will not accept all kinds of gifts and gratuities from Duties (No Gift Policy)

Therefore, in order to prevent conflicts of interest between one's own interests and common interests, accepting bribes, gifts, tokens or any other benefits that affect the performance of duties of Dongkhui Police Station. Therefore, guidelines for anti-bribery have been established. (Anti-Bribery Policy) and do not accept gifts, tokens or any other benefits (No Gift Policy) from performing duties. The details are as follows: objective

Article 1: This notice

'Supervisor' refers to the person who has the authority to command, supervise, supervise, and Inspection Officer

Bribery "refers to any property or other benefits given to a person to persuade them to take or refrain from taking any action in that position. Whether you like or dislike your responsibilities.

Fulfilling duties "refers to the behavior or performance of duties by government officials in designated positions. Or be assigned to perform any duties. Or as a police officer prescribed by law to perform any general and specific duties, or police station

Gifts, gifts, or any other benefits that affect the performance of duties refer to money and property. Any valuable services or benefits received by government officials, including tips, in addition to wages and income. Benefits obtained from the government under normal circumstances and affecting decision-making, approval, and licensing. Or any other act of performing duties in a manner conducive to corruption.

Article 2 Police officers at all levels shall:

1. Do not ask for, receive, give or accept bribes, gifts, gifts or any other benefits.

2. knowingly agreeing or acquiescing in giving or receiving gifts from family members;

Or any other interests of persons related to the performance of their duties.

3. When performing duties, we must extend law enforcement on the basis of fairness; It is very important to grasp the benefits and the image of the police; Do not take any action (conflict between personal interests and collective interests, such as accepting gifts, gifts or any other interests that affect the performance of duties, introducing

The resources of the central government are used for personal gain, exposing internal information and squeezing bureaucratic time into extra work.

4. Reduce the offer or acceptance of any other property or benefits in accordance with the Rules; and

The number designated by the country office is expressed by signing greeting cards, greeting cards and cards.

Expressing regret or using social media instead of giving things.

5. Refusal, intolerance, intolerance, not accepting bribes, gifts, gifts or any other benefits.

Perform duties, and promptly notify the director/stationmaster if any violation is found;

Article 3 The supervisor has the right to supervise, supervise and inspect the subordinate police officers.

Act in accordance with this announcement. Any violation of this announcement shall be reported to the director/

Station master, please inform me quickly.

Article 4 Anyone who finds any violation of this announcement may directly complain/inform the clues.

Through the stationmaster at Dongkhui Police Station or by telephone at 056 769 237, information about the personnel concerned is provided.

Complaint/clue providers will be strictly concealed and kept confidential.

Article 5 If a person concerned who receives a complaint/clue commits such a crime in a police station, he will be punished.

Investigate according to the situation, if illegal acts are found, severely punish th
